

I collect, save and use your personal data according to the regulations of the Data Protection Acts, especially the German Federal Data Protection Act and the German Telemedia Act. With this declaration I would like to inform you about which type of data I use for which purpose and the rights you have.

I would like to point out that, if there is the possibility to enter your personal data on my web page, only the especially marked mandatory fields are required to process the particular enquiry or your order. All further data are optional and will be used by me to optimize my offer and for statistical purposes, if necessary.

## **§1 Anonymized data collection and processing on this web page**

Log-file data will be collected automatically on my server and saved in an internal protocol file which is transferred to me via your browser.

The data are as follows:

- type and version of the browser used by you,
- type and version of the operating system used by you,
- URL of the web page which you have gotten to us from,
- search words which you have found our page with,
- date and time of recall of our web page,
- name of the sub-pages recalled by you.

I collect and process these data in anonymized form, which means: They can't be assigned to a certain person. Purpose of the data collection and processing is the analysis for internal system-related and statistical purposes.

## **§2 Utilization of your data**

I use your E-Mail address to complete a registration procedure on our pages with a confirmation E-Mail and to send you confirmation E-Mails for the orders you placed.

I only use your E-Mail address for transmission of my newsletter or other interesting offers for you if you have given me your consent to do so. You have the possibility to withdraw your consent at any time and to stop receiving the newsletters and E-Mails from my company. More information about your right of withdrawal can be found under § 5 "Right of opposition and right of withdrawal".

I pay attention to adapt my range to your demands at the best. In this context, I would like to point out that I

- carry out questioning of my registered customers as I am always interested in their

opinion about my product and service offer.

**You can withdraw the corresponding use of your data at any time by sending a short written message to the addresses stated below.**

Transmission of customer data to unauthorized third parties does not take place.

### **§3 Cookies**

For my web pages I use so-called „cookies“. Cookies are small text files which are stored on your computer and saved by your browser. By setting cookies, my web server can detect your browser, your individual adjustments on our web pages and, if necessary, parts of the registration data in coded form to make it easier to use my pages and to enable an automatic log-in.

In your browser adjustments, you have the possibility to refuse cookies, delete cookies from your computer, block cookies or to be asked before setting a cookie. Cookies set by me will be deleted from your computer after every session.

### **§4 Right to demand information, rectification, blocking and deletion of data**

Un request and free of charge, I provide information about your personal data saved, their origin, the recipients as well as the purpose of saving at any time. Information can be obtained by writing to the contact stated below.

Under legal conditions you have the right to rectify, block and delete these data. In this case, please also contact the address mentioned below.

### **§5 Right of opposition and right of withdrawal**

You have the right to contradict the use of your data for creation of user profiles and withdraw consents possibly given to us. In this case, we will omit processing your data for this purpose. The contradiction or withdrawal can be sent informally to me via mail or E-Mail without mentioning the reasons.
